▪ Exhibitors (which term will include the Applicant and any stand sharer) will be bound by the conditions, rules and regulations set forth in this agreement and any changes must be made in writing and signed by an authorized official of **New Horizon**. Who will have full power to interpret and to make or amend these rules, provided that such amendments and additions do not operate to diminish the rights reserved for the Exhibitor under this contract, and will not operate to increase liabilities of its Sponsors, Agents or Employees.

▪ No Exhibitor will be permitted to exhibit unless he has paid prior to the exhibition all of the fees agreed.

▪ Exhibitors are expected to comply with any building regulations and all Government rules and regulations.

▪ Rights of an exhibitor will not be assignable to any other firm or person and no exhibitor may assign his space, or sublet the whole or any part of the space to another party.

▪ An exhibitor has no right to occupy any particular space, although its requirements will be taken into account when it comes to allocating space.
